

**ANTI RAGGING COMMITTEE ENQUIRY REPORT ON CLASH BETWEEN  
STUDENTS HELD ON 05-05-2023**

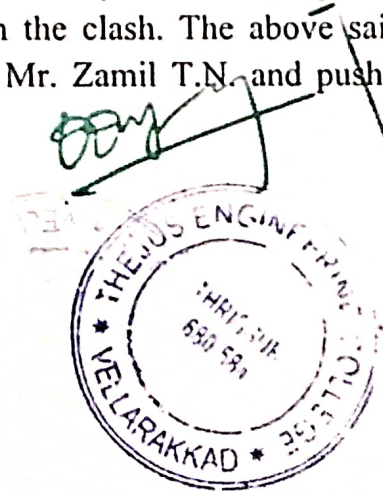
A clash between fourth semester computer science students and eighth semester mechanical engineering students took place in the ground floor premises of College on 05-05-2023.

A complaint was registered by Mr. Zamil T.N., S4 CS to Principal showing that he was ragged by Eighth Semester Mechanical Engineering Students (Mr. Athul Suresh, Nandu P. Pradeep, Irfan C.I., Arun T.A., Aswin Dharman). The same complaint was registered with Erumapetty Police station by the Complainant. The complaint was registered to the Antiragging Committee.

After issuing notice to all the involving parties, an enquiry by Antiragging Committee of Thejus Engineering College was conducted on 06<sup>th</sup> May 2023. Mr. Zamil T.N. (S4 CS) and Mr. Athul Suresh, Mr. Nandu P. Pradeep, Mr. Irfan C.I., Mr. Arun T.A., Aswin Dharman (S8 ME) were asked to report before enquiry committee at 10.00 am and 11.00 am respectively. According to Zamil T.N., the above said Mechanical Engineering students harassed him for wearing dhoti to college and Mr. Athul Suresh (S8, ME) beat him on his face and tore his shirt.

Nandu P. Pradeep, Irfan C.I., Arun T.A., Aswin Dharman appeared before the enquiry committee on 06-05-2023 and Athul Suresh was absent stating that he had a doctor's appointment on the same date. Hence he was asked to be present on 08-05-2023 before the enquiry committee. Mr. Athul Suresh denied the complaints against him and stated that he only talked to Mr. Zamil regarding why he wore dhoti to the college as it wasn't allowed and pushed him. Mr. Nandu P Pradeep (S8 ME) stated that he also pushed and shoved Mr. Zamil T.N.. Mr. Aswin Dharman and Mr. Arun T.A. (S8 ME) stated that they were with the others but were simply watching the incident. Mr. Irfan C.I. (S8 ME) stated that he raised his voice and talked to Mr. Zamil T A regarding wearing Dhoti to college.

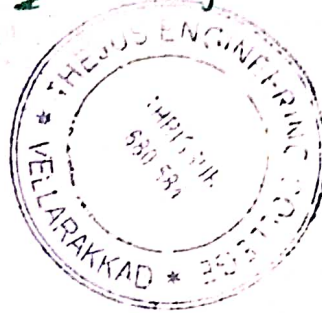
After speaking with the students, the Anti ragging Committee understood that the above said S8 Mechanical Engineering students had warned the fourth semester Computer Science students against wearing dhoti to college on 4<sup>th</sup> May 2023. The junior students wore dhoti the next day also (5<sup>th</sup> May) for their practice of Vattapattu for College Arts Celebrations. This aggrieved the Senior students which resulted in the clash. The above said Mechanical engineering students were responsible for shouting at Mr. Zamil T.N. and pushing him which resulted in his shirt being torn.
